

## Visitor Form Privacy Notice

### Collection and processing of personal data pursuant to article 12 et seq. of the General Data Protection Regulation (GDPR) and article 14 et seq. of the German Church Data Protection Act (KDG)

#### Purposes for which your personal data will be processed

Eighth Corona Control Ordinance of the State of Rhineland-Palatinate of 25 May 2020 (8th CoBeLVO)

Your health data is collected solely for the purpose of access control at Nardini Klinikum at the Zweibrücken and Landstuhl sites. The data will not be transferred to any third parties.

#### Who does provide your data to us?

As a matter of principle, we collect the required data, if possible, from you personally, unless the patient already provided your name, address, and contact information to us.

#### We process the following information for the purposes stated above:

Personal data:

- First name and last name
- Address
- Availability by telephone

#### Your data may be transferred to the following recipients:

None

#### How long will your data be stored?

Your data will be deleted on the patient's discharge.

#### Right to access, rectification, erasure

You are entitled to so-called data subject rights, i.e. rights which you may exercise as a data subject in an individual case.

You can assert these rights against the hospital operator. These rights are based on the General Data Protection Regulation of the European Union (EU-GDPR) and the German Church Data Protection Act (KDG):

right to access, art. 15 GDPR / art. 17 KDG. You have the right to access the personal data which is stored about you.

#### Right to rectification, art. 16 GDPR / art. 18 KDG

If you find that incorrect data concerning your person is processed, you may request rectification. Incomplete data shall be completed, taking into account the purpose of the processing.

#### Right to restriction of processing, art. 18 GDPR / art. 20 KDG

You have the right to restrict the processing of your data. This means that although your data will not be deleted, it will be marked to restrict its further processing or use.

#### Withdrawal of consent

If the processing of your data is based on a consent you gave to the hospital operator, you have the right to withdraw your consent at any time. You may send the declaration of withdrawal, by mail / e-mail / fax, to the hospital operator. You do not have to provide any reasons. Your withdrawal of consent becomes effective as of the time at which you declare it. It does not have a retrospective effect. The processing of your data until the time of your withdrawal of consent remains lawful.

#### Complaint to the regulatory authority about data protection violations

Irrespective of the fact that you may also take legal action, you have the right to complain to a regulatory authority, if you are of the opinion that the processing of your data is not permitted under data protection law. This right is based on art. 77 EU-GDPR / art. 48 KDG. You can lodge your complaint informally with the regulatory authority.
